IDPIC has been established as the nation's central digital payment fraud intelligence platform. Its primary mandate is to detect, prevent, and analyse fraud in India's rapidly expanding digital payments ecosystem in real time. Leveraging cutting-edge technologies, including Artificial Intelligence (AI), Machine Learning (ML), and Big Data Analytics, IDPIC plays a pivotal role in strengthening the security and trustworthiness of India's digital payment infrastructure.

#### Position Overview

The MD&CEO of IDPIC is responsible for providing visionary strategic leadership, operational direction, and oversight to ensure the successful delivery of IDPIC's mandate. The MD&CEO will spearhead the development and implementation of advanced fraud intelligence capabilities, foster strong partnerships with regulators, banks, technology partners, and other stakeholders to ensure cohesive ecosystem-wide fraud mitigation efforts. The role demands a seasoned leader with a strong background in banking, financial regulation, technology-driven risk management, and extensive experience in policy formulation and organisational leadership.

The applicant should possess a proven record of leading large organisations, preferably financial institutions, at the CEO level, with in-depth multidisciplinary knowledge and skills for capacity building, and be capable of understanding the banking needs and taking the company to greater heights in the years ahead.

**Qualification and Eligibility Criteria:** Graduate in any discipline. An MBA is preferable.

Should have worked for a minimum of 4 years as a Whole-time Director (out of which a minimum of 2.5 years as MD&CEO) in a Public Sector Bank or equivalent in a Private Sector Bank / Financial

organisation. Preference will be given to bankers with a proven track record of transformation, experience in leading IT-related committees, and a demonstrated ability to drive digital innovation in their organisation.

**Age limit:** Should be between 55 and 61 years as on 31.12.2025.

**Salary:** Monthly gross emoluments, accommodation, chauffeur-driven office car and other perquisites in tune with the industry norms in similar organisations.
